Dues: - \$275.00**

Eligible for MAC-ASHI Seminar discounts. Gets a seat at all monthly MAC-ASHI meetings, with advanced reservations.

Notes: You must be a Member or Associate of ASHI® to be a Member, Satellite Member, or an Auxiliary Member of MAC-ASHI.

Satellite Member: - A certified ASHI® Member or Associate in good standing and living further than 40 miles of the meeting place.

Dues: - \$75.00**

Receives all MAC-ASHI function announcements, one vote.

Eligible for MAC-ASHI Seminar discounts. Gets a seat at all monthly MAC-ASHI meetings, with advanced reservations.

Notes: You must pay \$30.00** for each dinner meeting. The 40 miles is measured from the address we have on file.

Auxiliary Member: - A certified ASHI® Member or Associate in good standing and holding a primary Membership in another ASHI® chapter.

Dues: - \$75.00**

Receives: all MAC-ASHI function announcements, does

NOT get a vote. Eligible for MAC-ASHI Seminar discounts. Gets a seat at all monthly MAC-ASHI meetings, with advanced reservations.

Notes: Eligibility to be determined by the Board of Directors. You must pay \$30.00** for each dinner meeting.

Affiliate Member: - A person involved in a business relating to housing or construction, but does not meet the requirements for Membership in ASHI®. Persons meeting these requirements include government housing inspectors, consumer affairs, real estate agents, contractors, suppliers, beginning inspectors or people thinking about getting into the business, etc.
